Proposed Action Title: Phytodetectors, Inc. -- Functional Engineering of a Photosynthetic Desalination Pump Circuit

Proposed Action Description:

FIRST AMENDED NEPA DETERMINATION: (See attached original Determination, March 26, 2020). This First Amended Determination follows the approval of additional funds and an extended period of performance to support the project team's small-scale research and development activities to design and engineer a genetic circuit encoding a synthetic water pump and demonstrate the commercial viability of photosynthetic desalination. The additional time and funds will be used to complete original project milestones that were delayed due to COVID-19 and perform additional work testing a genetic water pump circuit. Final research milestones will be completed and the additional time will also be used to begin drafting publication content. If successful, the project team will demonstrate a synthetic water pump circuit designed to take water flow processes in desalination plants from a passive to active process and increase the production of purified water derived from Photosynthetic Desalination 100-1000 fold.

Project activities will be conducted at existing facilities at Phytodetectors, Inc. (Wellington, CO) and Colorado State University (Fort Collins, CO) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to design and engineer a genetic circuit encoding a synthetic water pump and demonstrate the commercial viability of photosynthetic desalination. Specifically, the project team will (1) design a synthetic water pump, (2) target specific engineered components that actively transport water to plants, and (3) demonstrate a genetic water pump circuit, alone and in combination with the synthetic desalination genetic circuit (SDC) circuit/plants for continuous production of plant-derived water. If successful, the project team will demonstrate a synthetic water pump circuit designed to take water flow processes in our desalination plants from a passive to active process and in doing so increase the production of purified water derived from Photosynthetic Desalination 100-1000 fold.

Project activities will be conducted at existing facilities at Phytodetectors, Inc. (Wellington, CO) and Colorado State University (Fort Collins, CO) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.
