Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to R&D Dynamics Corporation for the design, development, fabrication, testing, and data analysis of an oil-free, foil bearing supported cathode compressor/expander and motor drive for heavy duty truck fuel cell systems. Design, development, fabrication, and testing activities would occur at R&D Dynamics facility in Bloomfield, Connecticut.

Budget Period 1 would include design and manufacturing activities with cost estimation as well as durability, reliability, and life testing occurring in Budget Period 2. Project activities would occur within a dedicated manufacturing and test facility designed for this type of work that would utilize standard equipment; therefore, no modifications, new permits, additional licenses and/or authorizations would be necessary. No ground disturbing activities, no changes in the operation of existing facilities, and no installation of equipment outdoors would occur for project activities. No hazardous materials would be used in the project. R&D Dynamics has a safety committee that meets quarterly to address any health and safety concerns. Policies and procedures would be implemented as necessary as new health and safety risks are identified. All waste would be recycled or disposed of in accordance with existing health and safety standards as well as applicable regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

FOR CATEGORICAL EXCLUSION DETERMINATIONS
