Proposed Action Title: Nokia of America Corporation -- Delivering Energy and Exergy Efficiency in the Converged 5G Radio Access Network (RAN)/EDGE Compute Network

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development of a highly efficient, resource-conserving thermal energy architecture that will simultaneously improve 1) artificial intelligence (AI) server cooling energy efficiency and 2) deliver high quality thermal energy that can be used directly for heating and cooling buildings. Specifically, the project team will develop a low-cost, passive two-phase cooling method. From chip to room scale, the proposed technology will re-architect computing infrastructure (e.g., processing power, storage, memory, and other resources) as a valuable heat source in a way that is practical and cost effective. If successful, this effort will produce technology to harness excess heat from computing hardware as energy for use of heating or cooling buildings and heating water, reducing fossil fuel combustion and energy costs.

Project activities will be conducted at existing facilities at Nokia Bell Labs (Murray Hill, NJ) and University of Illinois Urbana-Champaign (Urbana, IL) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
