Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Enact Systems, Inc. to develop an end-to-end platform for automation of sales, design and financing of projects utilizing operations, pricing and underwriting processes directly linked to, and qualified for, PACE programs and lenders.

Activities associated with the proposed project would include the design, development, testing and launch of a software platform that aids solar developers and financing providers in the financing of commercial solar projects leveraging the PACE (Property Assessed Clean Energy) structure. All software design and development activity would be completed at Enact Systems' headquarters in Pleasanton, CA. The proposed project activities would be limited exclusively to intellectual, academic, or analytical activities and would use no physical materials beyond basic office supplies and software.

Based on review of the project information and the above analysis, DOE has determined the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that this project is consistent with actions outlined in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination" and A11 "Technical advice and assistance to organizations" and is therefore categorically excluded from further NEPA review.
