Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Enact Systems, Inc. to offer solar developers a new level of transparency on their operational processes. Users will gain live, guided insights at every step of their workflow processes for sales and operations, and be able to benchmark all process steps and related costs on a live basis.

Activities associated with the proposed project would include design, development and testing of a software platform. The process to design such software will include customer usability research through online or in-person surveys and live videos, software product validation testing and software business partnerships with third-party data and technology providers. All technology development activities will be performed by employees and/or consultants employed by Enact at its headquarters in Pleasanton, CA. The proposed project activities would be limited exclusively to intellectual, academic, or analytical activities and would use no physical materials beyond basic office supplies and software.

Based on review of the project information and the above analysis, DOE has determined the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that this project is consistent with actions outlined in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination" and A11 "Technical advice and assistance to organizations" and is therefore categorically excluded from further NEPA review.
