Description:

Rationale for determination:

The Department of Energy (DOE) is proposing to provide funding to U.S. Forest Service, Region 6 in support of the proposed "U.S. Forest Service Pacific Northwest Region Photovoltaic Systems" project. U.S. Forest Service, Region 6 is proposing to install roof, ground, or carport-mounted solar arrays, ranging from 10–500 kilowatts, at 11 off-grid and remote Forest Service facilities across Oregon and Washington. This project was selected by DOE under the Assisting Federal Facilities with Energy Conservation Technologies (AFFECT) Funding Opportunity Announcement (DE-FOA-0001297).

The proposed project has not been defined to the extent that the DOE can complete a final NEPA determination at this time. This conditional NEPA determination applies solely to preliminary and planning activities as outlined in Tasks 1-3 of the Statement of Project Objectives (SOPO). Completion of these tasks is required in order to define the project to a degree that the DOE can complete a final NEPA determination.

The recipient is a federal agency and is also required to comply with NEPA. When the recipient has completed their NEPA review process for the proposed project, they will provide this information to the DOE in an EQ-1. The DOE will make a final NEPA Determination prior to authorizing the expenditure of DOE funding for issuance of a task order (Task 4), and implementation of the proposed project (Task 5).

DOE has determined that Tasks 1, 2 and 3 of the proposed project would not have a significant individual or cumulative impact to human health and/or the environment. Further, the DOE has determined that Tasks 1, 2 and 3 are consistent with CX A9 "Information gathering, analysis and dissemination" and are categorically excluded from further NEPA review.

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

Insert the following language in the award:

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

Prohibited actions include:

- Task 4: ESCO locks financing and agency awards the Task Order
- Task 5: Installation Period

This restriction does not preclude you from:

- Task 1: Finish Investment grade audits (IGAs) and final verification of viable solar installation locations
- Task 2: Perform Design on Selected Sites
- Task 3: ESCO completed task order for ESPC ENABLE

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.
