B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The Department of Energy (DOE) is proposing to provide funding to the State of Colorado Energy Office to design, procure, and install solar photovoltaic (PV) systems on client homes eligible under the Weatherization Assistance Program with Program Year 2018 funds. The PV systems would be installed on only eligible single family homes, as defined by the use of an energy audit which demonstrates that the savings over the life of the measure discounted to present value and outweigh the initial cost. No structural improvements of the roof or building would be made to any of the homes, beyond the necessary electrical connections and required racking system for the project. If the integrity of the roof would not support the additional weight of the solar panels, the panels may be ground mounted in the yard of the home. No trees would be removed for the installation of the PV systems. Each system would be net-metered with a grid connection. Installation of these systems would require additional wiring and electric breaker equipment to tie the solar PV system to the existing electric service for the home. All PV systems would be up to a 5kW system or smaller.

All permits from the local jurisdictions and agreements with the local electrical utility would be obtained. If any hazardous materials are identified during the installation of the PV systems, the hazardous materials would be managed or disposed of in accordance with applicable federal, state and local requirements.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
