Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Black Bear Hydro Partners, LLC (Black Bear) to test and validate a Whooshh Fish Transport System (WFTS) system for the safe passage of endangered Atlantic salmon into the Denil fishway at Milford Dam, in Milford CT.

The proposed project is divided into seven tasks.

Tasks 1 - 3 would include developing a project study plan, obtaining required permits (including assisting DOE with consultations required by the Endangered Species Act) and completing engineering designs for potential installation of the WFTS at the Milford Dam site. Tasks 1-3 would be analytical.

Tasks 4 – 7 would involve deployment and testing of the WFTS, as well as analysis of tests and reporting results. Deployment and testing would involve the handling and potential take of endangered species, specifically the Atlantic salmon. There is not enough information available at this time to conduct a review of these tasks.

Based on the review of the proposal, DOE has determined Tasks 1 - 3 fit within the class of action(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. Tasks 1-3 are categorically excluded from further NEPA review.

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
