Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.15 Small-scale

renewable energy research and development and pilot projects Small-scale renewable energy research and development projects and small-scale pilot projects, provided that the projects are located within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to Research Triangle Institute (RTI) to explore innovative approaches to maximize the yield of bio-crude from a catalytic biomass pyrolysis process and effectively and efficiently upgrade the bio-crude intermediate into a renewable diesel blendstock. The proposed project would be performed over three Budget Periods (BP) with a go/no-go decision after BP1 and BP2. The proposed project would focus on two objectives: (1) optimizing the physical characteristics of two biomass feedstocks (woody and herbaceous), in a commercially viable manner, to maximize bio-crude yields (independent of oxygen content) in catalytic biomass pyrolysis, and (2) improving bio-crude upgrading efficiency by fractionating the liquid intermediate and independently hydroprocessing each fraction to maximize biofuel production.

Project activities would be conducted at laboratory- and pilot-scale and would include verification of baseline data, feedstock preparation, characterization, testing, and modeling, catalyst preparation and evaluation, bio-crude testing, process integration and optimization, techno-economic analysis and project management. Work would be completed by RTI, Idaho National Laboratory, the National Renewable Energy Laboratory, Forest Concepts, LLC, and Haldor Topsoe in existing facilities that are purpose built for the type of work proposed. No modifications, changes to any of the facilities would be required, no disturbing activities would occur, and no new permits, licenses or authorizations would be required to perform the project.

Any work proposed to be conducted at a DOE laboratory may be subject to additional NEPA review by the cognizant DOE NEPA Compliance Officer for the specific DOE laboratory prior to initiating such work. Further, any work conducted at a DOE laboratory must meet the laboratory's health and safety requirements.

NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

DOE has determined that work to be carried out outside of the United States, its territories and possessions is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."

The proposed action is categorically excluded from further NEPA review.
