The purpose of this Modification is to update Contract Clause I-116 (j), entitled FAR 52.250-1 INDEMNIFICATION UNDER PUBLIC LAW 85-804 (APR 1984) ALTERNATE I (APR 1984) (DEVIATION) to add paragraph (4) as follows: "For purposes of implementation of Paragraph (j) of Contract Clause entitled I-116 FAR 52.250-1 indemnification under Public Law 85-804 (Alternate I) (APR 1984) (Deviation), the parties agree to the following: Los Alamos National Security, LLC is indemnified under P.L. 85-804 for activities directed or authorized by the Department of Energy, including National Nuclear Security Administration, on or after April 24, 2010, in response to the Deepwater Horizon disaster, per the Secretarial Determination Authorizing Public Law 85-804 Indemnification for Contractors Engaged in Activities Responding to the Deepwater Horizon Disaster, dated July 2, 2010."
