In FY 2019, DOE not only made progress in small business contracting overall, we also substantially increased awards to the four SBA-graded socioeconomic categories: Small Disadvantaged Business (SDB), Women-Owned Small Business (WOSB), Service-Disabled Veteran-Owned Small Business (SDVOSB), and Historically Underutilized Business Zone (HUBZone) businesses.

While DOE has more work to do to achieve socioeconomic goals, the prime and MOSRC numbers show that DOE has had positive trends across all four categories over the past 3 years. Despite today's rapidly changing environment for small businesses across the nation, OSDBU remains focused on continuing to support small and disadvantaged businesses, now more than ever. DOE will specifically continue to focus our efforts on maximizing small business opportunities for the socioeconomic categories identified herein.

# DEPARTMENT OF ENERGY'S ANNUAL SMALL BUSINESS FORUM AND EXPO

On August 17–19, 2020, DOE will be hosting this year's combined Small Business Forum and Expo and Summer '20 New Mexico Small Business Expo in Albuquerque, NM. The event will feature knowledgeable speakers, informative breakout sessions, great networking opportunities, the DOE Annual Small Business Award Program, and even the opportunity for One-on-One Matchmaking between participating buyers and interested small businesses.

Breakout sessions will include subjects such as:

- How Small Businesses Can Improve Their Proposals;
- How to Competitively Respond to DOE's Sources Sought;
- Methods for Communicating Your Past Performance to Accelerate Government Sales; and
- Doing Business with Different Parts of the DOE Procurement Community.

One-on-One Matchmaking "matches" small business "Suppliers" with participating "Buyers" represented by DOE Program Offices, Laboratories, site offices, other government agencies, and large business Prime Contractors. For a second consecutive year, OSDBU is arranging specific Mentor-Protégé Program (MPP) Matchmaking as part of the matchmaking sessions during the conference. # **AROUND THE INDUSTRY: THINGS TO WATCH**

**Please note:** During these difficult times, we will continue to send out daily SBA and SBAPAC updates to our SBPMs as legislation is introduced and approved to help small businesses move through the coming weeks and months ahead.

#### Unlocking Opportunities for Small Businesses Act of 2019

The <u>Unlocking Opportunities for Small Businesses Act of 2019</u> has been passed by the House of Representatives and has been sent to the Senate. This bill requires the past performance of a small business concern to be taken into account in certain situations.

#### Verification Alignment and Service-Disabled Business Adjustment Act

#### The Verification Alignment and Service-Disabled Business

Adjustment Act has been passed by the House and has been sent to the Senate. The Resolution transfers SDVOSB and VOSB certification from VA to SBA and requires certification government-wide. The transfer date would be 2 years after enactment, with 6-month extensions.

#### Women and Minority Equity Investment Act of 2019

The <u>Women and Minority Equity Investment Act of 2019</u> would change ownership requirements for WOSB and 8(a) programs for firms with venture-capital investment.

#### Small Business Contracting Accountability Act of 2019

The <u>Small Business Contracting Accountability Act of 2019</u> has been introduced in the Senate. This bill requires certain federal agencies (i.e., those with procurement powers) that are in violation of the requirement that they establish an Office of Small and Disadvantaged Business Utilization to submit a report detailing the reasons for their noncompliance and the specific actions they will take to comply with the requirement.

#### Changes to WOSB and EDWOSB Certification Process

In summer 2020, there will be changes to the certification process for WOSBs and EDWOSBs. After the changes go into effect, firms will no longer be able to self-certify as a WOSB or EDWOSB, and firms will have to either certify through an approved third-party entity or go through the SBA's FREE online certification process at <u>certify.sba.gov</u>.

#### New Beta.SAM.gov DataBank

The Module Transition to the new <u>Beta.SAM.gov</u> DataBank is planned for May 16, 2020. Following the conversion, government users will be asked to confirm their own results, and the Integrated Award Environment (IAE) will provide a conversion status report to each agency's IAE Change Control Board representative.

# Kansas City National Security Campus

The Kansas City National Security Campus (KCNSC) recently earned a Best Practice from the multi-site PERT review team for Small Business initiatives including its Small Business Forecasting Tool. KCNSC developed the tool to combine budget forecast information with historical spend by area by socioeconomic type to provide forward looking socioeconomic goals for each major area of spend within the site. A Small Business Steering Committee, comprised of leaders of each area of spend, helps set direction for the Small Business Program and drive the goals and requirements down through their organization.

The KCNSC and Pantex recently teamed with the DOE OSDBU to host a unique HUBZone Open House. Each HUBZone supplier at the event was provided the opportunity to be in the spotlight for a 3-minute introduction. The event also included networking and a presentation by the SBA.

## **Hanford Site**

The Office of River Protection (DOE-ORP), Richland Operations Office, Prime Contractors of both offices, and Pacific Northwest National Laboratory each have Small Business Program Managers (SBPMs) that make up the Hanford Small Business Council (HSBC). The HSBC serves as the advocate leaders in socioeconomic diversity for the Hanford Nuclear Site. Founded in 1998, the Council's mission is to provide increased procurement and business opportunities for small businesses. The Council also works diligently throughout each year to plan the annual <u>Bridging Partnerships Small Business</u> <u>Symposium</u>.

The Tri-Cities Area Journal of Business issued a specialty publication focused on Hanford in May 2019 that included a spotlight on small business contracting. DOE-ORP SBPM, Kelly Brazil was interviewed for this piece, along with various leaders from Hanford Prime Contractors and local small businesses. The Forecast Improvement Working Group (FIWG) is pleased to announce that we have drafted and approved a new charter. This charter will guide us in our mission to improve the quality and utility of the acquisition forecasts we provide for the DOE small business community. To that end, FIWG has already achieved a concrete improvement. The DOE HQ OSDBU Acquisition Forecast web-page link now takes users to a searchable, filterable spreadsheet instead of a PDF to dramatically improve usability.

We are moving forward with two main objectives:

#### Forecast Data Quality Improvements

Improve the data quality, timeliness, and streamline the collection and production of a reliable all-inclusive DOE forecast.

# Accessibility to and Utility of the Forecast Data

Significantly improve the accessibility of the data in a form and format that is easy to access and effectively utilize.
