THE NUCLEAR DECOMMISSIONING AUTHORITY IN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND

FOR EXCHANGE OF INFORMATION CONCERNING MANAGEMENT OF RADIOACTIVE WASTE

The Department of Energy of the United States of America and the Nuclear Decommissioning Authority in the United Kingdom of Great Britain and Northern Ireland,

BEING Participants of Statement of Intent No. 2 Between the Department of Energy of the United States of America and the Nuclear Decommissioning Authority in the United Kingdom of Great Britain and Northern Ireland for Exchange of Information Concerning Management of Radioactive Waste signed on February 24 and 28, 2012 (hereinafter the "Statement"), and

ACTING pursuant to Section 7.3 of the Statement,

HEREBY modify the Statement as follows:

- 1. The first paragraph of the Statement is deleted and replaced with the following:
 - "The Department of Energy (DOE) of the United States of America, Nuclear Decommissioning Authority (NDA) of the United Kingdom of Great Britain and Northern Ireland, and National Nuclear Laboratory Limited (NNL) of the United Kingdom of Great Britain and Northern Ireland, hereinafter collectively the 'Participants,'".
- 2. The title of the Statement is revised to "Statement of Intent Among the Department of Energy of the United States of America, Nuclear Decommissioning Authority of the United Kingdom of Great Britain and Northern Ireland, and National Nuclear Laboratory Limited of the United Kingdom of Great Britain and Northern Ireland for Exchange of Information Concerning Management of Radioactive Waste".
- 3. The opening paragraph of Section 1.1 is deleted and replaced with the following:
 - "The Participants intend to exchange information on the following subjects:"
- 4. Section 1.2(c) is modified by deleting "by either Participant" and replacing it with "by a Participant".
- 5. Section 2.1 is modified by deleting "each other's organizations" and replacing it with "another Participant's organization".
- 6. Section 4 is modified by deleting "to assist the other" and replacing it with "to assist the other Participants".
- 7. Section 7.2 is deleted and replaced with the following:
 - "The Participants may discontinue this Statement at any time by mutual consent in writing. Alternatively, a Participant wishing to discontinue its participation in this Statement should endeavor to give at least 30 days' notice in writing to the other Participants. A notice to discontinue participation operates to discontinue this Statement where either (a) the DOE serves such notice on the other Participants, or (b) both NDA and NNL serve such notice on DOE. The service of such a notice by either NDA or NNL alone does not operate to discontinue this Statement, but merely the participation in this Statement of the withdrawing Participant.
- 8. Section 7.3 is modified by deleting "of both Participants" and replacing it with "of all Participants".
- 9. This Modification is to take effect upon signature.
