AIR FLOW NORTH AMERICA CORP. FE DOCKET NO. 14-206-LNG

PROPOSED ACTION DESCRIPTION: Air Flow North America Corp. (Air Flow), a Delaware corporation with its primary place of business in The Woodlands, Texas, filed an application (Application) with the Office of Fossil Energy (FE) on December 16, 2014, seeking authorization to export domestically produced liquefied natural gas (LNG) from an existing natural gas liquefaction facility located in Willis, Texas (Facility) owned by Clean Energy Fuel Corp. The proposed exports of LNG will be loaded at the Facility into approved ISO IM07/TVAC ASME LNG (ISO) containers, then transported by trucks to, and loaded onto, container ships or roll-on/roll-off ocean-going carriers for export at ports in the Southeastern United States capable of handling ISO containers. The application was submitted pursuant to section 3 of the Natural Gas Act (NGA) and 10 CFR Part 590 of the Department of Energy's (DOE) regulations. No new facilities or modification to any existing facilities at the Facility are required in order for Air Flow to export LNG from the Facility. DOE/FE's proposed action is to authorize the exports described in Air Flow's Application if DOE/FE determines those exports are not inconsistent with the public interest.

[] There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not

precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
