NOTICE

This Notice amends the Notice of Noncompliance Determination issued in this case on February 14, 2013.

On February 14, 2013, the Department of Energy ("DOE") issued a Notice of Noncompliance Determination ("Noncompliance Determination") to QSSI Lighting & Electrical Products Group Inc. ("QSSI") finding 259 basic models of probe-start metal halide lamp fixtures do not comply with the applicable federal energy conservation standard.

The Noncompliance Determination incorrectly listed basic model FL70M250QBR rather than FL70M250QLBR as noncompliant. This Notice **AMENDS** the Noncompliance Determination to list instead basic model FL70M250QLBR as noncompliant, for the reasons stated in the Noncompliance Determination.

The Notice of Noncompliance Determination issued February 14, 2013, **REMAINS EFFECTIVE** for the remaining 258 metal halide lamp fixture models.

QSSI must take the following additional actions:

(1) Immediately cease distribution in commerce in the United States of all units of FL70M250QLBR manufactured on or after January 1, 2009;

(2) Provide immediate written notification of this noncompliance determination to all persons in the United States to whom QSSI has distributed units of FL70M250QLBR; and

(3) Provide to DOE within 15 calendar days of the date of this Notice a copy of the written notification required by paragraph (2) and a list of the parties QSSI notified.

(4) Within 30 calendar days of the date of this Notice, state the total quantity of any QSSI Basic Model (as identified in the February 14, 2013 Notice of Noncompliance Determination and including FL70M250QLBR) distributed in commerce in the United States after QSSI's October 2, 2012 subpoena response. If QSSI, Pacific Die Cast, or any other related entity manufactured (including importing) additional units, provide the number of units manufactured, the date of manufacture, and the new quantity remaining in inventory.

Provide complete information, using NA or 0 where appropriate. Below is a suggested format for your response.
