Proposed Action Title: Texas Tech University -- Novel Solid-State Neutron Detectors for Geothermal and Well Logging

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Lubbock, TX

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop large area neutron detector technology used in geothermal and well logging systems, to increase the detection efficiency and reduce manufacturing costs. Specifically, the project team will (1) develop the growth process used to create a key component of the neutron detector technology; (2) conduct detector processing, characterization and optimization; and (3) perform neutron detector testing in a laboratory. If successful, the project would lead to solid-state neutron detectors with increased reliability and versatility in extreme environments. If adopted, the detector technology will improve efficiency and reduce costs for new energy materials exploration and extraction in geothermal and well logging. The technology could also reduce downtime due to logging equipment failures, which can cost up to \$1-2 million per day of operations.

Project activities will be conducted at an existing facility at Texas Tech University (Lubbock, TX) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
