Proposed Action Title: Watford City Sub - Upgrades to 230kV breaker and associated equipment to accommodate an MDU interconnection.

Program or Field Office: Upper Great Plains Region - North Dakota

Location(s) (City/County/State): McKenzie County, North Dakota

Proposed Action Description:

Montana-Dakota Utilities (MDU) intends to build a new substation approximately 1,000 feet northwest of WAPA's existing Watford City Substation. MDU would also construct a short (~0.5 miles) 230kV line between the new substation and WAPA's substation. WAPA proposes to add a 230kV breaker and associated equipment to the Watford City Substation in order to accommodate MDU's new substation. The project area is located in Section 25 of Township 150 N, Range 99 W in McKenzie County, North Dakota.

The project is located in a highly developed area with no suitable wildlife habitat or sensitive biological resources, thus, there are no environmental concerns. The area in question has been previously surveyed by WAPA and SHPO concurrence has been received on our reports and findings. No additional cultural resources surveys are required.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
