- A. Brief Description of Proposal:** Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine maintenance to three structures on its Shiprock - Four Corners (SHR-FCO) 345-kV Transmission Line, located in San Juan County, New Mexico. Structures 5/3, 7/1 and 7/4 require maintenance to remove accumulated sand, sediment and vegetation from around the steel lattice footers and from inside the structure footprint. Due to the wind-blown soils along the transmission line, this maintenance is needed to help maintain the overall stability and longevity of the structures. Equipment utilized for structure maintenance would include track dozer, backhoe, skid-steer loader, utility trucks and other rubber-tired vehicles. To access the work area, maintenance crews would use existing access roads. No road maintenance activities are authorized as part of this Categorical Exclusion (CX). All work activities shall only occur within the 125-foot right-of-way (ROW) corridor at each structure location.

(1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally-recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- (2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- (3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR Part 1506.1 or 10 CFR Part 1021.211.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on November 27, 2021.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, WAPA’s Environmental Division must be contacted for an updated environmental review.
- 3) Any injured or dead birds encountered on WAPA’s ROW must be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR’s reporting requirements to the U.S. Fish and Wildlife Service.
- 4) Active avian nests must not be disturbed or damaged. An avian nest becomes active when the first egg is laid, and remains active until all offspring have fledged and the nest is empty. Any active nests located on WAPA’s transmission structures, substation equipment, or other areas that may threaten the safety of the nesting birds or pose a threat of fire hazard, mechanical failure, or power outage must be reported to the RMR Avian Protection Leads as soon as possible. Inactive nests that do not belong to threatened species, endangered species, or eagles may be removed and destroyed in accordance with WAPA’s Avian Protection Plan (APP). Contact RMR’s Environment Department prior to nest removal to ensure conformance with the APP.
- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR’s Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.

- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
 - 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
 - 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
- E. **Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
