A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace the existing overhead ground wire (OGW) with new fiber optic ground wire (OPGW) on its Boyd-Airport (BYD-ARP) 115-kV Transmission Line in Larimer County, Colorado; Airport-Windsor (ARP-WNY) 115-kV Transmission Line in Larimer and Weld Counties, Colorado; and Weld-Whitney (WLD-WNY) 115-kV Transmission Line in Weld County, Colorado. This project is part of WAPA's ongoing program to update and improve its communication system. In addition, WAPA also proposes to replace five existing wood H-frame structures along the BYD-ARP 115-kV Transmission Line. Structures 11/2, 11/4, 12/6, 14/7 and 15/7 will be replaced in-kind with new wood H-frame structures. All work would be confined to WAPA's existing right-of-way (ROW) and access roads on private lands.

The new OPGW would replace the existing OGW on these transmission lines. The OPGW would not be visibly different from the existing OGW. Equipment may include a helicopter, bucket trucks, wire pullers and tensioners, cranes, or work trucks used to install the new OPGW. The existing OGW would be used to pull the new OPGW into place, with "pulling sites" positioned at regular intervals to pull, wind, and remove the old OGW, and feed, tighten, and secure the new OPGW. In addition, the individual lengths of OPGW would be spliced together at regular intervals along the spans. Replacement of structures would include removing the existing structures, installing new wood poles, backfilling, and installing new hardware. Equipment for this project may include rubber-treaded vehicles (bucket trucks, truck-mounted augers, cranes, utility trucks, pickup trucks and a skid-steer loader). Existing access roads would be used; no road maintenance or road construction is authorized.

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2021**. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or dead birds encountered on WAPA's ROW shall be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 4) Active avian nests must not be disturbed or damaged. An avian nest becomes active when the first egg is laid, and remains active until all offspring have fledged and the nest is empty. Any active nests located on WAPA's transmission structures, substation equipment, or other areas that may threaten the safety of the nesting birds or pose a threat of fire hazard, mechanical failure, or power outage must be reported to the RMR Avian Protection Leads as soon as possible. Inactive nests that do not belong to threatened species, endangered species, or eagles may be removed and destroyed in accordance with WAPA's Avian Protection Plan (APP). Contact RMR's Environment Department prior to nest removal to ensure conformance with the APP.

- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
- **E.** <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
