A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace an existing wood H-frame structure and install new wood H-frame structures along its Whiterock - Stegall North (WRK-SG N) and Whiterock - Stegall South (WRK-SG S) 115-kV Transmission Lines located on private lands in Goshen County, Wyoming. The work is necessary to resolve clearance issues for the upcoming transport of high-profile oversized loads travelling under WAPA's lines. Structure 58/4 on the WRK-SG S line will be replaced with a taller wood H-frame structure. New wood H-frame structures will be installed between Structures 48/2 - 48/3; 54/6 - 54/7; and 57/1 - 57/2 on the WRK-SG N line and between Structures 49/4 - 49/5; 55/8 - 56/1; and 58/3 - 58/4 on the WRK-SG S line.

All new structures would have minor structural updates, but would be visually similar to the existing structures. The full scope of this project would include removing the existing structure, auguring new holes, installing new wood poles, backfilling, and installing new hardware. Equipment for this project may include rubber-treaded vehicles (bucket trucks, truck-mounted augers, cranes, utility trucks, pickup trucks, and a skid-steer loader). All work would be confined to WAPA's existing rights-of-way (ROW). Existing access roads would be used; no road maintenance or road construction is authorized.

An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- (2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on November 27, 2021**. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or dead birds encountered on WAPA's ROW must be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 4) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 5) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.

- 6) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 7) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
- E. <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
