**Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:**

Description:

**A11 Technical advice and assistance to organizations**

Technical advice and planning assistance to international, national, state, and local organizations.

**A9 Information gathering, analysis, and dissemination**

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

**B3.1 Site characterization and environmental monitoring**

Site characterization and environmental monitoring (including, but not limited to, siting, construction, modification, operation, and dismantlement and removal or otherwise proper closure (such as of a well) of characterization and monitoring devices, and siting, construction, and associated operation of a small-scale laboratory building or renovation of a room in an existing building for sample analysis). Such activities would be designed in conformance with applicable requirements and use best management practices to limit the potential effects of any resultant ground disturbance. Covered activities include, but are not limited to, site characterization and environmental monitoring under CERCLA and RCRA. (This class of actions excludes activities in aquatic environments. See B3.16 of this appendix for such activities.) Specific activities include, but are not limited to: (a) Geological, geophysical (such as gravity, magnetic, electrical, seismic, radar, and temperature gradient), geochemical, and engineering surveys and mapping, and the establishment of survey marks. Seismic techniques would not include large-scale reflection or refraction testing; (b) Installation and operation of field instruments (such as stream-gauging stations or flow-measuring devices, telemetry systems, geochemical monitoring tools, and geophysical exploration tools); (c) Drilling of wells for sampling or monitoring of groundwater or the vadose (unsaturated) zone, well logging, and installation of water-level recording devices in wells; (d) Aquifer and underground reservoir response testing; (e) Installation and operation of ambient air monitoring equipment; (f) Sampling and characterization of water, soil, rock, or contaminants (such as drilling using truck- or mobile-scale equipment, and modification, use, and plugging of boreholes); (g) Sampling and characterization of water effluents, air emissions, or solid waste streams; (h) Installation and operation of meteorological towers and associated activities (such as assessment of potential wind energy resources); (i) Sampling of flora or fauna; and (j) Archeological, historic, and cultural resource identification in compliance with 36 CFR part 800 and 43 CFR part 7.

Rationale for determination:

The U.S. Department of Energy's (DOE) Solar Energy Technology Office (SETO) is proposing to provide funding to the National Renewable Energy Laboratory and two partners, Oregon State University (OSU) and Pine Gate Renewables, as part of InSPIRE 2.0 Task 2, "Conduct Co-Located Field Research at Test Plots". The purpose of the proposed project is to study dryland crop production at locations where solar and agriculture are co-located, and would involve desktop and field studies to evaluate crop production levels within and outside of the shade produced by the solar arrays.

NREL would manage the overall project and provide technical support for the study design. OSU would conduct desktop and field studies at existing solar arrays owned by Pine Gate Renewables. Three Pine Gate Renewables solar array locations would be used for this study. Pine Valley and Grand Ronde are both located in Polk County, Oregon near Salem and Grand Ronde, respectively. Eagle Point is in Jackson County, Oregon near Medford. Vegetables were previously planted at study plots at the Grand Ronde and Eagle Point locations and would be used for this study, and OSU would plant vegetables at the Pine Valley array for this project.

OSU would take measurements from within the study plots at each of the three locations. Existing equipment would be used to provide sunlight and shading data, and vegetation height, cover, crop production, and vegetable size measurements would also be collected.

All proposed activities would occur on previously disturbed land and would not affect cultural resources, threatened or endangered species, wetlands, floodplains, or prime farmlands. No permits would be required. The proposed project would involve minor ground disturbance at the Pine Valley location during vegetable planting at the study plots. At the conclusion of the study at Pine Valley, the vegetables in the study plots would be removed and the ground reclaimed with natural vegetation. The proposed project would not involve modification or construction of facilities, no equipment would be installed, and pesticides would not be used. The project would not result in a change in the use, mission, or operation of the sites.

Mobile air emissions resulting from trucks and farming equipment would be negligible and short-term. Packaging and miscellaneous non-hazard waste used in establishing the study plot would be reused, recycled, or disposed of in a sanitary landfill as appropriate.

Workers could be exposed to physical hazards during the course of the proposed project. Existing corporate health and safety policies and procedures would be followed including employee training, proper protective equipment, engineering controls, proper material handling, monitoring, and internal assessments. Additional policies and procedures would be developed if additional health and safety risks are identified.

## NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

A migratory bird nesting survey would be completed if project activities involving ground disturbance occur between March 15 and September 15.

## FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
