Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the State of South Carolina Energy Office to design, purchase and install a 94kW roof mounted photovoltaic (PV) system that would include the installation of solar modules, inverters, mounting brackets, racking, PV wire, and conduit at 1059 Colite Drive West Columbia, SC a private industrial building.

The roof would not require any structural modifications, and no building modifications would be required, aside from electrical connections. The PV system would be grid connected, but no ground disturbance would occur. Local electrical permits and interconnection agreements with the utility company would be obtained.

Due to the close proximity, (less than two miles), of the Columbia Metropolitan Airport to the proposed project site, a glare hazard analysis was completed. The analysis showed no glare (or potential for after-image) for any flight path and no glare of any kind for the Air Traffic Control Tower.

The state of South Carolina must adhere to the terms of their DOE executed Historic Preservation Programmatic Agreement with their State Historic Preservation Office.

Any changes to the project activities or location is subject to additional NEPA review by DOE and are not authorized for Federal funding unless and until the Contracting Officer provides written authorization on those additions or modifications.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
