Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to Iowa State University (ISU) to develop a robust, passive, blade-mounted ultrasound deterrent to significantly reduce bat mortality in existing and new wind farms. The objective of the project is to design, develop, and demonstrate the ultrasonic sound generation capability of the bat-deterrent device in laboratory tests.

Proposed project activities include design, development, fabrication and laboratory testing of a passive ultrasonic bat-deterrent device. All of the activities would occur at the Iowa State University located in Ames, Iowa. Fabrication of the devices (approximately 5"x4"x1") would be done using 3D printing. No testing would be performed on bats or other live animals. Experiments would be performed in an anechoic chamber for measurement of sound produced by the proposed devices and in the wind tunnel to test the aerodynamic performance of the blade when these devices are mounted on a blade section.

No new permits or modifications to permits are required to perform the planned activities. And, no modifications to the existing facilities are planned or expected.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
