Description:

Rationale for determination:

The U.S. Department of Energy is proposing to provide federal funding to North Carolina State University to develop a Photovoltaic (PV) Analysis and Response Support (PARS) platform that provides real-time situational awareness and optimal response plan selection. The objective of the project would be to improve the grid support function performance of hybrid PV systems, specifically with respect to visibility, dispatchability, security, and reliability.

Project activities would include 1) preparing data requests 2) data processing and analysis for model parameterization, forecasting, anomaly detection, and decisions making. 3) running simulation models to predict system behaviors 4) developing algorithms and 5) cost-benefit studies.

The PARS platform would run on computers and in-the-loop simulation test beds in Raleigh, NC, Richland, WA, and White Plains, NY.

NEPA PROVISION

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
