Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to [GeothermEx](#) to compile and evaluate real-time drilling data (collected by Schlumberger and non-Schlumberger systems) from up to 50 geothermal wells to assess the causes of drilling inefficiencies, particularly those that affect Rate of Penetration (ROP).

The proposed project would involve the use of an advanced software system to analyze data and develop new algorithms to identify the main operational problems in geothermal drilling, their root causes, and correlations with physical and operational parameters. No drill sites would be developed or modified by the project for the purposes of collecting new data and/or testing the results of desktop analyses. The proposed technical scope of work is limited exclusively to intellectual, academic, or analytical activities. All work would be conducted at the Recipient's offices in San Francisco, CA. No physical materials beyond basic office supplies and computers would be required for the proposed activities.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
