Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Arizona State University (ASU) to discover new materials through fundamental quantum mechanics investigations (computational and computer modeling methods) for improved solar thermochemical hydrogen systems. Only BP1 was originally negotiated and was reviewed by GFO-0008090-001 in July 2017. There was a Go/No Go decision point after BP1 that was passed so this NEPA review is for the remaining project activities.

The work will primarily take place in Tempe, Arizona at ASU and project partner's Princeton University's facilities in New Jersey. Collaboration is expected to occur with the HydroGEN Energy Materials Network National Laboratory consortium.

The project is limited exclusively to intellectual, academic, or analytical activities. The proposed project activities include model development, computational calculations, and analysis on the thermodynamics of complex metal oxides that have mixed ionic electronic conductivity. No modifications to buildings or new permits, additional licenses and/or authorizations are expected to be required as a result of the proposed project.

NEPA PROVISION

DOE has made a final NEPA determination.
