During an evaluation of radiological dose, it was discovered that an error was made in the calculation of dose at the ambient air monitoring stations involving the misapplication of the conversion factor converting concentration to dose. The following corrections to the report referenced above have been made to respond to this error.

<b><u>Page</u></b>	<b><u>Correction</u></b>
4-6	Section 4.3.4, third paragraph, last sentence. Corrected the ambient air dose as follows: “The net dose for each station ranged from 0 at stations with a lower dose than the background station to 0.20 mrem/year at station A9, which is near the southwestern corner of the PORTS property boundary.”
4-6	Section 4.3.4, fourth paragraph. Revised the paragraph as follows: “The highest net dose measured at the ambient air monitoring stations (0.20 mrem/year at station A9) is less than the 10 mrem/year NESHAP limit for airborne radiological releases and 100 mrem/year DOE limit for all radiological releases from a facility.”
4-17	Section 4.6.1, last paragraph, second sentence. Corrected the ambient air dose as follows: “The highest net dose calculation for the off-site ambient air stations (0.20 mrem/year) was at station A9, which is southwest of the plant on Old U.S. Route 23.”

For example, 3.4E-04 is 0.00034 (the decimal point moves four places to the left); 2.1E+02 is 210 (the decimal point moves two places to the right).

<sup>c</sup>The total dose is provided in scientific notation and standard numeric format (in parentheses).

<sup>d</sup>The net dose is calculated by subtracting the total dose at Station A37 (background) from the total dose calculated for each station (the net dose is recorded as zero for stations with a gross dose less than the background station). The net dose is provided in scientific notation and standard numeric format (in parentheses).
