The responsibility to contact me by telephone -- and to follow-up our telephone discussion promptly with documentation by facsimile to me and to the cognizant program Associate Director(s) -- is in addition to the weekly telephone conferences we have initiated to discuss more routine programmatic and operational issues.

ESTABLISHMENT OF THE OFFICE OF ENVIRONMENTAL RESTORATION AND WASTE MANAGEMENT

DATE: 11-9-89

On October 4, 1989, I approved the establishment of the Office of Environmental Restoration and Waste Management (EM). The implementation date for EM is November 1, 1989. I will be recommending legislation to Congress to create an Assistant Secretary for Environmental Restoration and Waste Management. I am designating Mr. Leo P. Duffy as the Office Director for this organization. He will also continue his current role as Special Assistant to the Secretary for Coordination of DOE Waste Management pending appointment of the Director of the Office of Civilian Radioactive Waste Management.

The EM Office consolidates environmental cleanup, compliance and waste management activities identified in the Five-Year Plan. EM will provide centralized management and planning and focused headquarters' control and validation of cost, schedule and priority of environmental restoration and waste management projects at DOE facilities not actively used for production. A Memorandum of Agreement has been executed between EM and other DOE offices to clarify their respective roles and responsibilities. The Office will also administer an aggressive Environmental Restoration and Waste Management applied research and technology development program.

DOE Operations Offices will continue to be responsible for the execution of projects at their sites and will appropriately propose realigning their organizations to implement the Five-Year Plan. Each DOE Operations Office will recommend those facilities which will be under the cognizance of EM. Any realignment of Operations Offices functions determined necessary to effectively manage the facilities will be submitted as a proposed organization change in consultation with affected Program Assistant Secretaries and the Assistant Secretary, Management and Administration. Approval of changes will be made by the Secretary.

Final implementation procedures, which include the transfer of environmental cleanup, compliance, and waste management activities that were previously assigned to the Offices of Defense Programs, Nuclear Energy and Energy Research are underway and will be completed within the coming weeks.

The attached organization chart (Attachment A) reflects the structure of the organization. Attachment B designates Acting Officials to be effective on the date of this Notice.


