- A. Brief Description of Proposal:** Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct geotechnical investigations near its Kimball Substation (KB) located in Kimball County, Nebraska. The proposed work would occur on private and WAPA owned lands south and east of the KB. This project is intended to support the future expansion of the KB for the construction of a 4 breaker 115-kV ring bus.

A total of three 3.5” diameter boreholes will be drilled to obtain geotechnical data in support of the proposed expansion of the KB. Work will be conducted using a truck mounted auger. The borehole locations will be accessed via existing access roads and overland travel; no road maintenance or new road construction is authorized, and only rubber-treaded vehicles will be used.

**B. Special Stipulations Pertaining to the Proposal:**

- 1) If the scope of work of this project changes, RMR’s Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on February 28, 2020.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
- 3) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR’s reporting requirements to the U.S. Fish and Wildlife Service.
- 4) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR’s Archaeologist must be contacted immediately at (970) 461-7563. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.
- 5) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR’s Archaeologist must be notified immediately at (970) 461-7563 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR’s Archaeologist.

- 6) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 7) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
