Proposed Action Title: Gila - Gila Valley: 2019 Integrated Vegetation Management

Program or Field Office: Western Area Power Administration - Desert Southwest Region

Location(s) (City/County/State): Yuma County, AZ

Proposed Action Description:

The Western Area Power Administration (WAPA) is proposing to reduce incompatible vegetation and fuel loading within the Right-of-Way (ROW) along the Gila (GLA) to Gila Valley (GIV) transmission line segment (approx. 3 miles). Proposed work includes cutting and/or trimming trees and shrubs beginning at the GLA substation, ending at the terminus of the GIV segment. All vegetative debris would be collected and hauled away on trucks. The project area would be accessed via existing roads in the ROW. The work would be accomplished using bucket trucks and chainsaws (hand-cutting only). Existing access roads are determined to be sufficient for use, and as such, overland travel, access road maintenance, or any ground disturbance are not authorized.

The proposed work is needed to maintain the safe operation and reliability of the bulk electrical system.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
