A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace damaged wooden H-frame structures along its Sidney-Big Springs (SDT-BSG) 115-kV Transmission Line. Structure replacements will occur between Structure 143 and Structure 149 located on private lands in Cheyenne County, Nebraska. The existing wooden H-frame structures will be replaced in-kind with new wooden structures. The full scope of this project will include removing the existing structures, installing new wood poles, backfilling, and installing new hardware. Equipment for this project may include rubber-treaded vehicles (bucket trucks, truck-mounted augers, cranes, utility trucks, pickup trucks and a skid-steer loader). All work will be confined to WAPA's right-of-way (ROW) easement. Existing access routes will be used; no road maintenance or road construction is authorized.

This Categorical Exclusion (CX) replaces the original CX issued May 21, 2018, with an original expiration date of December 31, 2019. The proposed action remains the same, but has been renamed to reflect recent changes in line designations. The Special Stipulations (Section B, below) have been updated for this CX and replace all original CX stipulations.

B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2021.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 4) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 461-7563 or (970) 461-7214. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.

- 5) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 461-7563 or (970) 461-7214 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 6) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 7) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
