Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Iowa State University in Ames, IA (ISU) for the development of new energy efficiency techniques for laser surface drying in microelectronics wafer fabrication.

Proposed activities at ISU would include computer modeling to study the physics of water behavior during the drying process and to assess the efficiency and effectiveness of various drying conditions. A hybrid simulation of computer modeling and physical testing would be conducted to evaluate the effect of wafer dopant levels and to develop strategies for industry scale deployment. The University of Nebraska in Lincoln, NE (UNL) would also support the project by developing a laboratory based laser surface drying system to study the effects of various laser parameters. Adding to ISU efforts, UNL would perform additional analysis on the effect of drying conditions to increase drying efficiency and effectiveness on silicon wafers. UNL would then design a large-scale laser drying scanning system to test the drying effectiveness.

The project would require the use and handling of various hazardous materials. All handling of hazardous materials would occur in a laboratory and would be managed in accordance with existing safety policies, and follow Federal, state, and local environmental regulations. No modifications, new permits or change in the use, mission, or operation of any facility would be required.

FOR CATEGORICAL EXCLUSION DETERMINATIONS
