Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Confluence Communications to leverage existing infrastructure and content previously developed to design model curriculums for four academic programs: high school, "boot camp" for transitioning workers, 2-year associate's degree, and continuing education for homebuilders. The project would design each of these curriculums so they could be utilized by other similar programs around the country, thus increasing the focus of energy efficiency in the construction trades.

This project is limited to curriculum and content development, program evaluation and recommendation, and the augmentation of existing DOE tools to include multimedia content, in addition to stakeholder engagement and outreach. No physical structures or equipment would be funded. All deliverables would be in the form of multimedia content, national model program recommendations, and stakeholder engagement and outreach plans. All project activities would consist exclusively of intellectual, academic, or analytical activities such as information gathering, data analysis, and data dissemination.
