Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to United Technologies Research Center (UTRC) to develop and demonstrate a method for moisture removal in which an alternating electric field is applied to a surface in a manner that momentarily detaches droplets from the surface and facilitates their removal. Project work would occur within existing facilities at UTRC in Harford, Connecticut. The project would be completed over two Budget Periods.

Project work includes the modeling of evaporation and moisture removal from material surface structures, optimization of input parameters, scaled experimentation on representative surface samples, comparison of measured and simulated parameters, quantification of benefits to actual applications, and recommendations for larger scale implementation. These activities would utilize standard laboratory equipment and would occur in existing laboratories designed for this type of work; therefore no major modifications, new permits, additional licenses and/or authorizations would be necessary. No ground disturbing activities, no changes in operation of existing facilities, and no installation of equipment outdoors would occur as part of the project. The project would involve the application of a high-voltage electric field to sample surfaces. Experiments would be designed according to UTRC Environmental, Health and Safety (EH&S) guidelines and undergo appropriate risk assessment and mitigation prior to implementation to help ensure project activities do not pose any risk to employees or the public. All waste would be handled and disposed of in accordance with existing EH&S procedures and would comply with all Federal, state, and local regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
