Proposed Action Title: Otherlab, Inc. -- Hydraulically Actuated Near-Isothermal Compressor

Proposed Action Description:

AMENDED NEPA DETERMINATION: (See attached original Determination, dated January 23, 2019)

This Amended Determination follows the approval of additional funds and milestones to support the project team's small-scale, research and development activities to retrofit its compressor prototype to increase the ranges of design parameters that may be tested within it. Specifically, the project team will (1) retrofit its prototype; (2) revise its thermodynamic and predictive performance models; (3) redesign subcomponents for desired performance; and (4) assemble and test performance. If successful, the project team will demonstrate a laboratory prototype of a commercially relevant compressor with a compression ratio of 15:1 and an efficiency that is approximately double of current commercial compressors.

Project activities will be conducted at an existing facility at Otherlab, Inc. (San Francisco, CA) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
