A. Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to remove all WAPA-owned substation equipment at the Malta (MAL) Substation. The MAL Substation is owned by the Public Service Company of Colorado (PSCo), and all WAPA-owned equipment will be replaced with PSCo-owned equipment. Equipment that will be removed includes: two 230-kV circuit breakers (5146 and 5147), three 230-kV disconnect switches (5147S, 5147N, and 5146S), one ground switch (5147G), two duplex control boards with relays and controls, and associated equipment. Following the equipment removal, PSCO will have full ownership and maintenance responsibilities for all substation equipment at the MAL Substation. WAPA will maintain full ownership and maintenance responsibilities for all of its communications equipment located in the MAL Substation, including the microwave radio and antenna to Mount Elbert Switchyard, as well as maintenance responsibility for the Bureau of Reclamation's radio equipment for Granite Peak. WAPA will also maintain ownership of the Mt. Elbert-Malta (MTE-MAL) 230-kV Transmission Line. The equipment removal will be completed by PSCo and funded by WAPA. PSCo will also be responsible for the appropriate disposal of all removed equipment. This work will occur within the existing fenced perimeter of the MAL Substation. No disturbance outside the fenced perimeter will occur.

#### B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2022.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Lead-based paint, asbestos, PCB, and other environmentally regulated materials requirements must be met.
- 4) Certification of proper disposal of equipment and regulated materials must be provided to RMR's Environment Department, rmr-environment@wapa.gov, within 30 days of disposal. The WAPA project number, 2019-004, must be included in all correspondence.
- 5) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP). Copies of this plan can be obtained by contacting RMR's Environment Department.
- 6) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 461-7563 or (970) 461-7214. Work in

the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.

- 7) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 461-7563 or (970) 461-7214 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 8) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.

with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
- **E.** <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
