Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Sunvapor, Inc. to design, develop, and demonstrate a novel steam accumulator for solar industrial steam applications that would enable the cost-effective integration of solar steam with a typical manufacturing process.

The project would consist of three budget periods (BP). Associated activities would include design, market study, industry outreach, and small-scale research and development (BP1) as well as the engineering, installation, testing, and operation of a solar steam system incorporating the developed components (BP2/BP3). Because demonstration activities would take place at a yet-to-be identified industrial host site, most likely a steam-consuming manufacturing plant, there is not sufficient information available at this time to review BP2/BP3. Therefore this NEPA Determination is for BP1 only; further NEPA review will be required if the project receives approval from the Solar Energy Technologies Office to move forward into subsequent budget periods.

BP1 would not involve construction or any other site-based activities, as initial project tasks would be focused largely on identifying potential industry partners and securing a host site alongside concept validation via thermofluid design, simulation, and optimization. All BP1 activities would take place at Sunvapor in Pasadena, CA. No change in the use, mission, or operation of existing facilities would arise out of this effort.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
