Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, Information gathering, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Lane Community College (LCC) to develop an educational program that would prepare participants for professions in the building energy management sector. The program would build on existing Energy Management and Building Controls (EM/BC) programs currently offered by LCC. These programs would be developed further through the creation of an apprenticeship program and a peer mentoring program. Program participants would be connected with industry partners and complete a hands-on apprenticeship. An educational component would be developed for the program. This component would be provided via an online platform.

Proposed work activities would consist of stakeholder engagement, participant recruitment, educational program development, preparation of training materials, and classroom/virtual training. Approximately 122 participants would be recruited through workshop, career fairs, and online engagement. Participants would be placed with an industry partner as part of a paid apprenticeship program and would perform work activities specific to the position. Participants would perform routine work activities under the supervision of the industry partner. These activities would be performed regardless of DOE funding.

Work activities for the DOE funded project would be limited to office-based program development and stakeholder engagement. No installation or field work would be performed. No change in the use, mission, or operation of existing facilities would be required as part of this project. Similarly, no additional permits would be required in order to conduct any of the work activities.
