Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Vermont Energy Investment Corporation (VEIC) to create a zero-energy modular (ZEM) construction package of processes and protocols that produce standardized ZEM multifamily homes. Project activities include development of construction evaluation protocols (modeling, measurement, quality assurance); design and finalization of construction plans for multifamily ZEM buildings (energy efficiency, building design) and factory (building plans, factory design); development and delivery of a quality management system (QMS) and training curriculum for local workforce development programs (including one train the trainer training); and creation and dissemination of open-source blueprints of the factory and ZEM modular multifamily building design. Project work would be completed over three Budget Periods (BPs) with Go/No-Go decision points between each BP. No construction, field tests, or demonstration projects would occur under this award. All project activities would consist exclusively of intellectual, academic, or analytical activities such as information gathering, data analysis, and data dissemination.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
