Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to ExOne Company for the design, manufacture, and testing of ceramic materials from the coupon level to the heat exchanger component level. Specifically, design efforts would include analysis, 3D modeling, and engineering design. Manufacturing activities would be comprised of 3D printing of coupons, sub components, and heat exchanger prototypes. Testing would focus on material property evaluations at the coupon level up to system level testing. The project would be completed over three Budget Periods (BPs). This NEPA determination is applicable to all three BPs.

Proposed project activities by location are listed below:

The ExOne Company - North Huntingdon, PA and St. Clairsville, OH

- Project management including technical, financial, and legal reviews, 3D printing, and material characterization testing

Oak Ridge National Laboratory - Oak Ridge TN

- Materials and process engineering, material characterization, heat exchanger testing and evaluation

Lawrence Livermore National Laboratory – Livermore, CA

- Heat exchanger design and material characterization

The project would involve the use and handling of hazardous materials, including solvents, phenolic binder solutions, and ceramic powders. Handling of hazard materials would take place in a laboratory setting with personal protection equipment, and down draft systems for work with ceramic powders. All hazardous materials would be managed in accordance with federal, state and local environmental regulations.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
