Project Title: H-02 Constructed Wetland Studies – Terrestrial Food Web Monitoring

Proposed Action or Project Description:

This research will quantify levels of metals in birds using the A-01 and H-02 treatment wetlands as foraging habitat. Birds will be captured via mist nets from the H02 wetland and associated streams (Crouch Branch and Upper Three Runs), A01 wetlands, and as well as from unaffected streams in the north western portion of the SRS (e.g., northwestern Upper Three Runs and Tinker Creek). Bird specimens will be taken to SREL's 737-A Laboratory for metals analysis.

This proposal would not threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of Appendix B to Subpart D of 10 CFR Part 1021; involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.
