Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the International Center for Appropriate and Sustainable Technology (ICAST) to develop a business modeling approach to provide access to solar PV and/or solar PV plus storage to Low-and-Medium Income (LMI) households living in multifamily affordable housing (MFAH) properties.

This project would be completed over three Budget Periods (BPs) with a Go/No-Go Decision Point in between each BP. ICAST received a conditional NEPA Determination for the project in February, 2019 (GFO-0008568-001; CX A9), which reviewed BP1 tasks. Since that time, all tasks associated with BP2 and BP3 have been defined and a Go Decision has been reached. Therefore, this NEPA Determination is to review remaining project activities.

Proposed activities would center on the development of a business model to aggregate demand from multiple MFAH properties into a single solar investment. ICAST would act as the technical assistance advisor to utility partners in developing low income solar programs where multifamily housing entities are the off-takers. The utilities would select the sites, release the request for proposal (RFPs), select the developers, and own and operate any new solar installations. ICAST would help develop the preliminary financial models only.

All project activities would be completed by ICAST (Lakewood, CO). BP2 and BP3 would consist entirely of officebased tasks (e.g., computer modeling and analysis, reporting, and stakeholder engagement). No installations or field work would be performed under this award. Accordingly, no change in the use, mission, or operation of any existing facilities would arise out of these efforts, nor would any additional permits or authorizations be needed for the completion of project work.
