AMENDED NEPA DETERMINATION: (See attached original Determination, dated November 19, 2013)

This Amended Determination follows the approval of additional funds and milestones to support the project team's small-scale, research and development activities to develop and demonstrate a non-flammable, high energy-density, Lithium-ion battery. Specifically, the project team will mitigate technology risks needed to adopt the UMD-developed battery in a portable application. If successful, the project team will demonstrate the capability of garnet solid-state electrolyte to significantly improve the safety, lifetime, and energy density of commercially available lithium ion batteries.

Project activities will be conducted at existing facilities at University of Maryland, College Park (College Park, MD) and Ion Storage Systems (College Park, MD) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
