<u>Proposed Action Title</u>: University of Maryland, College Park -- Hybridized Mg2+/H+ Aqueous Chemistry as High Energy and Safe Rechargeable Battery for Vehicle Electrification

## **Proposed Action Description:**

AMENDED NEPA DETERMINATION: (See attached original Determination, dated August 17, 2016)

This Amended Determination follows changes to the project team and additional funds and milestones to support the project team's small-scale, research and development activities to further enhance the energy density of its water-in-salt electrolyte batteries. Specifically, the project team will (1) explore and optimize new fabrication methods; (2) demonstrate and evaluate its fuel cells for various applications; and (3) implement new technology to market strategies. If successful, the project team will develop a low cost, safe, flexible and energy dense battery, deployable in various mobile and stationary applications.

Project activities will be conducted at existing facilities at the University of Maryland, College Park (College Park, MD) and Saft American, Inc. (Cockeysville, MD) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
