<u>Proposed Action Title</u>: Other Lab, Inc. -- SeaSTAR: Selective Thalassic Ambulatory Retriever (STAR), A Robotic Platform for Deep Sea Mining of Polymetallic Nodules

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Francisco, CA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a more environmentally-friendly, less energy-intensive method of mining polymetallic nodules; picking them directly from the ocean floor with robotic arms and depositing them directly into a vacuum to the surface. Specifically, the project team will (1) develop and test nodule localizing sensor array and robot arms; (2) develop nodule seeking behavior in simulation, and harden and test system components for depth and temperature; and (3) develop full nodule collector design and demonstrate walking and picking behavior in simulation. If successful, the project team will demonstrate a system that will reduce the cost of mining operations by reducing the mass transported to the surface, and significantly reduce the impact of deep sea mining by minimizing contact with and disruption of the ocean floor.

Project activities will be conducted at an existing facility at Other Lab, Inc. (San Francisco, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
