Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and development, laboratory operations. and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

# Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Akron to design, develop, fabricate, and test a recyclable lightweight carbon fiber composite as well as perform techno-economic assessment and life cycle analysis of the product. The recipient would create a composite that is energy efficient to produce and retains most of its tensile strength after several recycling and reprocessing cycles. In addition, the material would allow for retrieval of the carbon fiber at the end of the product lifespan. The project would be completed over three Budget Periods (BPs) with a Go/No-Go Decision Point between each BP. This NEPA review is applicable to all three BPs.

Proposed project activities by location are listed below:

University of Akron - Akron, OH

· Design, develop, fabricate, and test recyclable thermoset composites.

Pacific Northwest National Laboratory - Richland, WA

· Research and development involving injection, compression molding, and resin transfer molding of cross-linkable resin into solid form.

Raytheon Technologies Corporation - Farmington, CT

• Perform techno-economic assessment and life cycle analysis.

Project activities would involve the use and handling of hazardous materials, including organic reagents and solvents. Any risks associated with the handling of these materials would be mitigated through adherence to established health and safety policies and procedures. Protocols would include personnel training, the use of personal protective equipment, monitoring, internal assessments, and engineering controls. All waste products would be disposed of by licensed waste management service providers. University of Akron and its project partners would observe all applicable Federal, state, and local health, safety, and environmental regulations. No modifications, new permits, or change in the use, mission, or operation of any facility would be required.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

## FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
