Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations Technical advice and planning assistance to international, national, state, and local organizations.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Southface Energy Institute to develop the Distributed Energy Resources Education Center (DEREC) which would include a resource database with online coursework, technical publications, and registration opportunities for live (in-person or virtual) training events as part of a national initiative to promote implementation of distributed energy resources (DERs). The proposed project activities include the collection of information related to the specifications, design, code permitting, and inspections of DERs; analysis of the collected information to determine impediments to ready adoption and implementation of DERs; curriculum development of educational materials for improving adoption and implementation of DERs; and, offering live and prerecorded trainings in person and online. Project work would be completed over two Budget Periods (BPs) with Go/No-Go decision points between each BP. All project activities would consist exclusively of intellectual, academic, or analytical activities such as information gathering, data analysis, and data dissemination.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
