This is a final response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You requested:

All records concerning FOIA request logs maintained by the Department of Energy from April 1 to April 30, 2021.

Your request was assigned to Department of Energy's Office of Public Information (MA-46) to conduct searches of its files for responsive documents.

MA-46 conducted a search and identified one (1) document responsive to your request. Upon review, DOE has determined the responsive document should be released in its entirety.

The adequacy of the search may be appealed within 90 calendar days from your receipt of this letter pursuant 10 C.F.R. § 1004.8. Appeals should be addressed to Director, Office of Hearings and Appeals, HG-1, L'Enfant Plaza, U.S. Department of Energy, 1000 Independence Avenue, S.W., Washington, DC 20585-1615. The written appeal, including the envelope, must clearly indicate, that FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov including the phrase "Freedom of Information Appeal" in the subject line, (This is the method preferred by the Office of Hearings and Appeal. The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, a judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
