The Purpose of this modification is to Exercise OPTION TERM 1 for CLINs 0001C and 0002B in accordance with Clauses F-5 EVALUATION OF PERFORMANCE AND EXERCISE OF OPTION(S) and I-4, FAR 52.217-9, OPTION TO EXTEND THE TERM OF THE CONTRACT. As a result, the Contract is modified as follows:

1. Section B, Clause B-2 CONTRACT TYPE AND VALUE, paragraph (b), Table 1 -- CLIN 0001C -- Management and Operation of NSC, delete “(if exercised)” from Contract Period Option Term 1.
2. Section B, Clause B-2 CONTRACT TYPE AND VALUE, paragraph (c), Table 2 -- CLIN 0002B -- Work for Others and Other reimbursable Work, delete “(if exercised)” from Contract Period Option Term 1.
3. Section B, Clause B-3 CONTRACT FEE STRUCTURES, paragraph (a), is replaced in its entirety as follows:
 - (a) Fixed fees (Work for Others) and available award fee. The fixed fees (Work for Others) and available award fee for the Base Term and each Option Term, if exercised by DOE/NNSA, are shown in the tables in paragraph B-2, Contract Type and Value. The Contractor shall be eligible to earn award fee of **\$186,041,000** during the Base Term (CLIN 0001B) **and Option Term 1 (CLIN 0001C)**, in accordance with (b)(ii) of this clause and B-5, Performance Evaluation.
4. Section F, Clause F-3 PERIOD OF PERFORMANCE, paragraph (3), Option Term 1, delete “If exercised, one year from the end of the Base Term” and replace in its entirety as follows:

Option Term 1: 1 October 2020 through 30 September 2021
5. All other terms and conditions remain unchanged.
