On behalf of the Brazosport Area Chamber of Commerce Board of Directors, we hereby write to support the request in the above referenced docket of Freeport LNG Expansion, L.P., FLNG Liquefaction, LLC, FLNG Liquefaction 2, LLC and FLNG Liquefaction 3, LLC (collectively "Freeport LNG") to the U.S. Department of Energy to increase export capacity at their LNG Liquefaction and Export Terminal in Brazoria County, Texas.

LNG exports have and will continue to stabilize U.S. natural gas production, which in turn generates billions of dollars in new investments, benefiting local communities, producing tax revenues and creating jobs.
