On behalf of the Economic Development Alliance for Brazoria County, I hereby write to support the request in the above referenced docket of Freeport LNG Expansion, L.P., FLNG Liquefaction, LLC, FLNG Liquefaction 2, LLC and FLNG Liquefaction 3, LLC (collectively "Freeport LNG") to the U. S. Department of Energy to increase export capacity at their LNG Liquefaction and Export Terminal in Brazoria County, Texas.

LNG exports have, and will continue to, stabilize U.S. natural gas production, which in turn generates billions of dollars in new investments, benefiting local communities, producing tax revenues and creating jobs.<sup>1</sup> Moreover, LNG exports are key to national and international efforts to reduce emissions, with global facilities investing billions in low-carbon and no-carbon solutions. Internationally, LNG exports support our allies' efforts to reach net-zero emissions, allowing them to generate electricity with natural gas versus higher-emitting energy sources.
